<u>2017 WRESTLING TOURNAMENT REGULATIONS AND INSTRUCTIONS</u> - Take what information is needed from these rules for your District Meets.

1. The members of the Southwest District Athletic Board adopted the following regulation per a recommendation from the Wrestling Coaches' Representatives:

Coaches are required to wear dress slacks or khakis, a shirt with a collar, and appropriate footwear, such as sneakers, dress shoes, etc. Flip flops and sandals are examples of inappropriate footwear. Coaches dressed inappropriately will not be permitted to be on the mat.

The Southwest District Athletic Board adopted the following policy effective with the 2017 tournaments: Athletes being recognized on the award stand cannot be wearing hats, hoddies, or other head gear while being recognized.

- 2. Managers can seed up to six (6) wrestlers per class. For an individual to be seeded he must have wrestled twelve (12) matches this season and attained a .500 record. The seed meeting will be held during weigh-ins. Rev. 1-27-15.
- 3. Seed meeting can be held after 7:00 p.m. on Thursday. Team roster must be submitted before 7:00 p.m. on Thursday. The team roster must include the current varsity record of each wrestler submitted. Also included should be wrestler's weight last year and place in state and district meets. Additional information pertinent to seeding is covered in item 10.6, "Seeding Criteria in the OHSAA Individual Wrestling Regulations".
- 4. Weigh-ins will be conducted at the tournament site prior to the first day competition in accordance with NF Rule 4-5-3. Weigh-ins for subsequent day(s) may be conducted during the evening preceding each subsequent day(s) competition. The tournament manager shall set weigh-ins within these limits.
- 5. The minimum weight as listed on the Alpha-Master Roster and the wrestler weigh-in sheet must be provided to the tournament manager prior to starting the tournament.
- 6. Certification by Board motion: 1) A doctor or certified trainer must be present to check all athletes. 2) Tournament managers shall accept a state certified form signed by a physician relating to skin infection. 3) A registered wrestling official shall be employed to conduct weigh-ins. Board adopted April 12, 1997.
- 7. Officials fees: If an official works Friday night only, pay will be \$55.00. If an official works just Saturday of a two-day sectional tournament, pay will be \$190.00. If an official works the entire sectional tournament, pay will be \$245.00. Pay for officials working the entire district tournament will be \$315.00.
- 8. Admission for a one-day sectional tournament will be \$12.00 for the first session and second session (combined) and \$7.00 for the finals. All session pass will be \$15.00.
 - Admission for a two-day sectional tournament will be \$6.00 for the first session, \$6.00 for the second session and \$7.00 for the finals. All session pass will be \$15.00.
 - Admission for a two-day district tournament will be \$12.00 for the first and second session (combined), \$6.00 for session three, and \$7.00 for session four (finals). All session pass will be \$22.00.
- Each manager will be responsible for admittance of contestants, managers, cheerleaders and cheerleader advisors for all Sectional and District tournaments
 - Athletic Directors, Superintendents and Principals will use their yearly passes that have been mailed to them. Tournament managers will see that these passes should be used by school Administrators.
- 10. The only persons permitted in the wrestling area will be the wrestler and two (2) coaches. Violations will result in the removal of the coach from the wrestling area. A maximum of six (6) cheerleaders, in uniform and accompanied by an advisor, will be permitted to the Sectional/District Tournaments. They will be permitted only in

the area designated by the Tournament Manager. (Board Action)

- 11. All weigh-ins shall be conducted by weight class (coaches recommendation 4-28-01).
- 12. All tournaments are to score all six places at the sectional level (coaches recommendation 4-28-01).
- 13. MANAGERS AND COACHES will adhere to the State regulations. Rules and regulations may be obtained from the OHSAA web site.
- 14. Division I Wrestling Tournaments will consist of two open draws—In the south one sectional at Lebanon and one at Hamilton. In the north, there will be two sectionals at Centerville. Per direction of the State Board of Control, all teams in a bracketed tournament will be seeded. The manager will distribute voting materials and procedures to each coach prior to the start of the Tournament Manager's Meeting. This will enable each coach to vote and have his votes back to the tournament manager by Saturday, Noon, January 28, 2017, before the Tournament Manager's Meeting on Sunday, January 29, 2017, 2:00 p.m. The tournament manager will either distribute in written form or verbalize the team seed voting of all coaches in the tournament on the day of the Manager's Meeting. All ties will be broken prior to the placement of teams on the bracket.

In an Open Draw and non-bracketed tournament (Division I in the North and South, and Division II—Graham (sectionals 1 & 2), if a coach does not show up at the draw meeting, the manager will place the team in the sectional with the most open spots. If there is a tie in open spots, the manager will flip a coin to determine placement. This placement will occur in order as pre-determined by the coaches' votes.

By board action, starting with the 2011-2012 tournaments, the coach cannot vote for his school in the seeding process, and the highest and lowest votes for each school will be dropped in the final tabulation.

By board action, starting with the 2013 spring tournaments, a coach that does not vote in a bracketed tournament loses his highest score, second highest score, and the lowest score prior to final calculation.

By board action, starting with the 2016-2017 tournaments, schools that fail to have their coach participate in the online seeding process (record records, voting, etc., or fail to attend draw meeting) will be fined \$150.00. An appeal process will be in place until the next Southwest Board meeting, March 8, 2017.

15. Qualifiers from Sectionals to District Tournaments:

Division I Each sectional will qualify the top four (4) wrestlers in each weight class to the district tournament.

Division II Top four (4) in each weight class from Graham 1 & 2 and Batavia and top four (4) from Southeast

sectionals will qualify for District at Wilmington High School.

Division III Top four (4) qualifiers from Blanchester, and Lehman will qualify for district at Hobart

Arena along with top four (4) from Central and Northwest sectionals. (Rev. 12-29-15)

The District Wrestling Tournament will be held on Friday, March 3, 2017 and Saturday, March 4, 2017 at the following sites:

Division I Kettering Fairmont Trent Arena

Division II Wilmington H.S.
Division III Hobart Arena

16. Qualifiers to the State Meet will be four (4) in Division I, four (4) in Division II, and four (4) in Division III per weight class.

17. Team changes are as follows:

Sectional/District

All wrestlers who make weight and are eligible to wrestle

Each school will be allowed additional people based on number of competitors—one to six (1-6) competitors will receive four (4) additional passes, seven to ten (7-10) competitors will receive five (5) additional passes, and eleven to fourteen (11-14) will receive six (6) additional passes. These passes are for coaches, stats, managers,

and support personnel.

Cheerleaders – A maximum of six (6) in uniforms, along with an advisor.

- 18. All Sectional Managers are to send their results of their Tournaments to the District Tournament Manager by Sunday, February 26, 2017, at 10:00 a.m.
- District Tournament Managers must submit a time schedule for their respective meet.
- 20. By District Board Action. A new Weather Cancellation Policy was adopted:

The Southwest District Board has established the following policy for cancellation or postponement of tournaments.

Schools participating in wrestling tournaments and reside in a county that experiences a Level Two (2) or Level Three (3) weather emergency, that SITE (tournament) will be postponed. Tournament managers must contact the District Board and make every effort to personally contact each schools coach, athletic director, or principal.

Schools are also encouraged to make use of the Board website (www.swdab.org) for updated information regarding postponements and cancellations.

The tournament manager will contact the Board Secretary, who will work with the managers to contact the "News Media".

Prior to the start of tournaments, the managers will be instructed to make available to the Board, a contingency plan for weather emergencies.
